President Karen Carter called the regular meeting of the Board of School Trustees to order. The pledge of allegiance was recited.

Call to Order

Director of technology services, Jason Inman, recited the Elkhart Promise.

Brad Sheppard, assistant superintendent of instruction, presented an overview of the Instructional Leadership Departments plan on prioritizing for student success. Dr. Sheppard introduced his staff members present: Beth Williams, director of federal programs; Phil Lederach, director of secondary instruction; Tara White, director of literacy; and Mr. Molyneaux. Dr. Sheppard stressed the importance of simplicity, clarity and priority. The three highlighted elements were: what to teach, how to teach, and authentic literacy. Professional learning communities are key to the implementation of the elements. Mr. Molyneaux stated one of the learning objectives is to increase strategies for ways students can demonstrate what they have learned. Mrs. White commented on the work being done in professional learning communities and staff training. Dr. Sheppard closed the presentation with the department's priorities: simple, well-known strategies and structures.

MEMORANDUM OF UNDERSTANDING
BETWEEN ELKHART COMMUNITY SCHOOLS AND
CHARLOTTE MITTLER REGARDING
ADVANCED MANUFACTURING CENTER

This Memorandum of Understanding is entered into between the ELKHART COMMUNITY SCHOOLS ("ECS") and CHARLOTTE MITTLER ("MITTLER") on the 5th day of October, 2018 in order to memorialize the intentions of the parties regarding the construction of an Advanced Manufacturing Center on property owned by ECS.

ECS is a school corporation operating under the laws of the State of Indiana. ECS provides programming for students enrolled in its schools from pre-kindergarten through grade twelve, along with adult education programming, and additionally operates the Elkhart Area Career Center ("EACC"). EACC provides Career and Technical Education programming to high school students enrolled in ECS high schools, along with fourteen other school districts' high schools in Indiana and Michigan. ECS as part of its strategic plan will be merging its two high schools beginning with the 2020-21 school year to become Elkhart High School. Beginning with the 2021-22 school year ECS will open Elkhart High School ("EHS"). EHS will operate a Freshman Division on the current campus of Elkhart Central High School and provide programming for students in grades ten through twelve on the current campus of Elkhart Memorial High School ("EMHS"), the current EACC and in a new building to be constructed between EMHS and EACC.

ECS intends to construct a new facility ("the ETI Building") on the campus of the current Elkhart Memorial High School and the adjoining Elkhart Area Career Center that will house the school of Engineering, Technology and Innovation ("ETI") along with an Advanced Manufacturing Center to be operated as part of Elkhart High School, while simultaneously providing opportunities to students participating in programming offered by the Elkhart Area Career Center and additionally to community members through the Adult and Community Education programs operated by ECS.

MITTLER has expressed a willingness to support the ETI School, the Advanced Manufacturing Center, and the construction of the ETI Building to house the same, provided that the ETI Building includes spaces to address the needs of EHS and the EACC, while also providing opportunities for working adults to develop skills needed by area industries. An Advanced Manufacturing Center will be embedded in the ETI Building to support each of these areas. A two story structure consisting of spaces for public and school use is planned and will include the following: offices spaces to oversee the various programs, a bistro for students and patrons, a centrally located collaboration/presentation space, sixteen general purpose classrooms, a general technology lab, a computer aided design lab, a welding lab, a machine trades lab, a mechatronics

lab, an automation lab, a robotics lab, along with restrooms and support spaces. So as to accomplish the foregoing the parties specifically intend the following:

1. ECS shall initiate the process required under the Indiana Code for financing the construction of the ETI Building in an amount of not less than five million (\$5,000,000.00) dollars.
 - a. ECS through its governing body and related ECS Building Corporation shall authorize indebtedness through the issuance of bonds to be used for the construction of the ETI Building on or before February 1, 2019.
 - b. ECS shall also place for sale said bonds on or before June 30, 2019.
 - c. ECS shall engage the services of a design criteria developer ("DCD") on or before January 1, 2019 to oversee the development of criteria necessary to initiate the design/build process for the ETI Building.
 - d. ECS shall offer the opportunity for MITTLER to appoint a member of the technical review committee ("TRC") for the selection of a design/build contractor, and may also provide MITTLER or her designee with the opportunity to observe and contribute to the work of the TRC.
 - e. The Governing Body for ECS shall select the design/build contractor on or before March 1, 2019
2. ECS will also seek other funding sources, including but not limited to community donors, with the intent to secure an additional two million five hundred thousand (\$2,500,000.00) dollars to assist with funding for the construction and equipping of the ETI Building
3. MITTLER agrees to contribute to ECS an amount equivalent to twenty-five (25%) of the cost of constructing and equipping the ETI Building (estimated to be a total project cost of ten million (\$10,000,000.00 dollars), but not more than two million five hundred thousand (\$2,500,000.00) towards the construction of the ETI Building. MITTLER shall commence making payment of its contributions to ECS subsequent to the Governing Body for ECS entering into a written contract with the design/build contractor and shall make all payments of its contribution during the course of construction as mutually agreed upon by the parties. Final payment to ECS shall be made no later than the 85% completion mark as evidenced by progress billing provided to ECS.
4. ECS in recognition of the contribution made by MITTLER shall collaborate with MITTLER on an appropriate form of recognition of said contribution, and the contributions of Thomas Mittler to the larger community.

STUDENT FUNDRAISING

| The Board acknowledges ~~that~~ the solicitation of funds by or from students must be limited.

| For purposes of this policy, "student fundraising" shall include the solicitation and collection of money by or from students for any purpose and shall include the collection of money in exchange for tickets, papers, or any other goods or services for approved student activities.

The Board may permit student fundraising by students in school, on school property, or at any school-sponsored event only when the profit therefrom is to be used for school purposes or for an activity connected with the schools. The Board requires ~~that~~ for any fundraiser by student clubs and organizations, as well as by Corporation-support organizations, which involve the sale to students of food items and/or beverages to be consumed on campus, the food and/or beverage items to be sold comply with the current USDA Dietary Guidelines for Americans or SMART snacks guidelines.

Fundraising by approved school support organizations, that is, those organizations whose funds are managed by the Corporation, may be permitted in school by the principal. Such fundraising off school grounds may be permitted by the Superintendent.

Fundraising by students on behalf of school-related organizations whose funds are not managed by the Corporation may be permitted on school grounds by the Superintendent.

| The Board may permit fundraising ~~that~~ which involves any games of chance, such as bingo games, charity game nights, raffles, door prizes, fundraising festivals, activities related to pull tabs, punch-boards, tip-boards, and the like. However, any fundraiser involving games of chance must comply with Indiana law, including obtaining the appropriate license or permits.

Involvement of students under the age of eighteen (18) in fundraisers involving games of chance is limited as follows:

In compliance with I.C. 4-32. 2-5-21, no student under the age of eighteen (18) may play or participate in any of the following types of fundraising events - bingo games, charity game nights, raffle, door prizes, fundraising festivals, activities related to pull tabs, punch-boards, tip-boards, and the like. No student under the age of eighteen (18) may sell tickets for any of the following types of fund-raising events - bingo games, charity game nights, door prizes, fundraising festivals, activities related to pull tabs, punch-boards, tip-boards, and the like. Students, even those under eighteen (18) years of age, may sell tickets or chances for a raffle.

All other fundraising by Corporation support organizations shall be done in accordance with Board Policy 9211 and Policy 9700.

The Superintendent shall include

A. Philosophy

It is important for Elkhart Community Schools to protect the safety of all students within the district, encourage and support the positive image of Elkhart Community Schools, recognize the increased competition for available contributions to worthy organizations, and avoid the appearance of pressure, intimidation, or annoyance during school sponsored fundraising activities.

B. Guidelines

1. School sponsored fundraising activities should follow certain general guidelines. The activities should discourage door-to-door solicitation, bring people into the schools, provide buyers with fair return for money spent, indicate the school-related purpose for the fundraising event, minimize competition with local businesses, avoid promoting activities contradictory to appropriate educational goals, and allow for direct contributions to individual schools subject to Board approval, as appropriate.
2. This policy applies to the use of any form of crowdfunding utilizing an online service or website-based platform for the financial benefit or gain of the School Corporation — be it a specific classroom, grade level, department, school, or curricular or extra-curricular activity. For purposes of this policy.

“crowdfunding” refers to a campaign to collect typically small amounts of money from a large number of individuals to finance a project or fundraiser for a specific cause. Through the use of personal networking, social media platforms, and other Internet based resources, funds are solicited or raised to support a specific campaign or project.

Crowdfunding activities aimed at raising funds for a specific classroom or school activity, including extra-curricular activity, or to obtain supplemental resources (e.g., supplies or equipment) which are not required to provide a free appropriate public education to any students in the classroom may be permitted, but only with the specific approval of the Board.

Employees are discouraged from accepting cash donations and or check written out to them as an individual.

The Superintendent shall develop and regularly update a list of approved crowdfunding websites/services, and staff members are permitted to conduct crowdfunding campaigns using one of the approved sites/services only.

C. Procedures

School sponsored fundraisers must have the prior approval of the Board of School Trustees. Administrators seeking the approval of the Board must submit a written request to the Business office which includes the following information:

1. description of the proposed fundraising activity
2. school employee responsible for the fundraising activity
3. school employee responsible for the collection of proceeds from the fundraising activity
4. school employee responsible for the ordering of products, and
5. restrictions (if any) on the use of the proceeds from the fundraising activity

Subsequent to receipt of the forgoing information, the Business Office will submit the request to the Board of School Trustee for review.

The Superintendent shall distribute this policy to each organization granted permission to solicit funds.

Solicitation by Students or Staff

The solicitation of funds by school classes, organizations, students, or staff is subject to the following:

- A. Solicitation of the public must be approved by the appropriate building principal(s) or the Assistant Superintendent for Instruction for solicitations involving more than one building.
- B. Solicitation of staff by students or students by staff is discouraged.
- C. Solicitation by sale of school pictures, book club programs, class rings, school publications, concessions, and book store items to students on school property requires principal approval.

Fundraising by School Support Organizations

All fundraising activities should be conducted in such a way that the best educational interests of students are served, and the interest of the general public in the quiet enjoyment of home and hearth is preserved. Sections 1(A), 1(B) and 2, above, should be used by School Support Organizations as a guide for their fundraising activities.

Students selected for the Early College program typically will be the first in their family to go to college, and often come from low-income backgrounds. They haven't done anything like this before. Many students will take their first train ride. Many students will see their first skyscrapers. They will make funny faces and take pictures with their friends at Cloudgate (the Bean) and strike silly poses next to 50-million-dollar paintings. They will see 5000-year-old Buddha statues and trace the development of European art from medieval times to Impressionism, examining how social forces like the Protestant Reformation and the Industrial Revolution shaped and ultimately democratized art.</p> <p>This instructional unit will be engaging because not only do students have the field trip as a motivator, but they also will see real connections between the subjects they are studying. Unit activities would take place in U.S. History, Geometry, and English 11. In U.S. History students will study the history of the city from its founding to the Columbian Exposition of 1893, with special attention to the Loop area. In English 11, students will study Erik Larson's book <i>The Devil in the White City</i>, a nonfiction account of the Columbian Exposition. They will also analyze and research art held in the Art Institute of Chicago with special attention to the Impressionist works produced in the late-nineteenth century. In Geometry, students will apply math skills to planning their dream trip to the city with detailed itineraries and budgets that account for meals, lodging, and transportation.</p> <p>How will this grant support the vision of Elkhart Community Schools? In the very near future, all high school teachers will be working on interdisciplinary teams to provide students with opportunities such as the one that this unit offers students.
