Eligibility

The Elkhart High School Fight Song Lyric Submission contest is open to all, including staff, students, parents, community members, and alumni. There are no age or location requirements for participation.

Submission Guidelines

Submissions must be received by **11:59pm on Friday, January 31, 2020**. It is preferred that submissions are sent via email to Dan Burton at <u>dburton@elkhart.k12.in.us</u>. Submissions can also be mailed to Attn. Dan Burton at Pierre Moran Middle School, 200 W Lusher Ave, Elkhart, IN 46517, or dropped off in person at the Pierre Moran school office.

Intellectual Property Release

By submitting lyrics, entrants understand that Elkhart Community Schools will have the right, where permitted by law, without any further notice, to review or consent to print, publish, broadcast, distribute, arrange, and use, worldwide in any media now or hereafter known in perpetuity and throughout the world, your entry. Each entrant who submits lyrics hereby irrevocably grants, transfers, sells, assigns and conveys to Elkhart Community Schools, their successors and assigns, all present and future right, title and interest of every kind and nature whatsoever, including, without limitation, all copyrights, and all rights incidental, subsidiary, ancillary or allied thereto (including, without limitation, all derivative rights).

Selection Process

Submissions will be reviewed by the Elkhart High School Fight Song Committee, comprised of ECS staff, students, and board members. The committee may select a single submission or portions of multiple submissions. The author or authors of the selected lyrics will be notified and named at a later date. Without limitation, the entry and winner's name, portrait, picture, voice, likeness, image and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes may be used without any further compensation.
